a) Learning Objectives:

The learning objectives of the course mainly address the skills identified as: most demanded by the labour market; having the lowest degree of coverage in the existing courses and programmes; less subject to obsolescence. These skills are:

- create and effectively commercialize mobile apps;
- enhance their business;
- user understanding;
- design skills.

b) Entry Requirements:

In order to be able to follow this course and achieve the learning objectives and outcomes, a certain number of pre-requisites were requested: basic knowledge of computational thinking (abstraction, algorithms, decomposition and pattern recognition); basic knowledge of business management; basic knowledge of computer science / software engineering; basic knowledge of programming basics (Java, C++ and C#); utilise event driven programming; utilise data modelling; create prototyping; identify basic requirements; produce prototype; assess prototype - discuss; modify and enhance prototype; develop and code on one or more mobile operating systems: iOS, Android, Windows Phone; have basic knowledge of mobile hardware architecture.

c) Duration:

The AppSkil course is 60 hours long (*15 for each module*), with 21 learning outcomes, the duration of which is estimated to approximately 3 hours each.

d) Structure of the Course:

The AppSkil Course comprises four modules: Module 1 - Business Management; Module 2 - Marketing Channels; Module 3 - Development of the App; Module 4 - Project Management.

The course was delivered in presence and the methodology of the case studies was applied.
